Community benefit

Prisma Health annually reports our community benefit figures. Net costs of charity and Medicaid services, along with support to the community and community health partners, are reported using guidelines set by the Catholic Health Association.

We also include bad debt and Medicare shortfall figures, as those are taken at a loss to our organization in the interest of providing care to all patients.

The percentage of operating expense recognized as community benefit for our health company in FY21 was 15.4%.

Ongoing response to COVID-19

For those needing hospitalization, Prisma Health treated 30% of the state’s COVID-19 patients. Some people avoided or reduced hospital stays and severe illness by receiving monoclonal antibodies early on in their disease.

In January, Prisma Health created mass vaccination sites at several of our facilities, taking a leadership role in the Midlands and Upstate. At the vaccination peak Jan. 22, 9,656 shots were administered. Additionally, six mobile units were outfitted to dispense vaccinations, targeting residents in our rural and underserved areas.

In large part due to COVID-19, Prisma Health’s virtual care platforms logged more than 413,000 visits by video, phone or eVisit. These options have been particularly helpful for people reluctant to seek on-site care for other health concerns during the pandemic.

Because testing remains key in managing the impact of coronavirus in our communities, Prisma Health continued to provide COVID-19 tests, with many being administered at drive-thru sites in our communities.

Quick adaptability has proven essential to our coronavirus response, perhaps best exemplified by Prisma Health North Greenville Hospital. When cases declined in the spring, the hospital transitioned back from being a COVID-19 facility since March 2020 to providing long-term acute care. As cases then reached record highs in late summer and beyond, the hospital again stepped up to treat many patients with COVID-19, focusing on those needing extra recovery time.

New programs and services

Two new physician training programs were approved in FY21: Clinical Informatics and Rheumatology, bringing our graduate medical education program totals to 63 residencies and fellowships. These academic offerings enhance our ability to create the clinical workforce we need for the future. Nearly 2/3 of our newly graduated residents and fellows who remained in South Carolina chose to practice with Prisma Health.

Our organization announced the formation of a Transplant Center in response to rising community needs. South Carolina ranks second per capita for those on the waiting list for kidney transplants. One of two in the state and 253 nationwide, the Transplant Center began seeing patients in Greenville in fall 2021.

Prisma Health Patewood Hospital opened a Breastfeeding and Newborn Care Center. The center helps ensure a seamless transition from hospital to home for breastfeeding moms and their newborns.

Prisma Health Richland Hospital is first in the state – and among the first in the nation – to use deep-brain stimulation to treat movement disorders such as Parkinson’s disease. The surgery involves implanting thin electrical wires into specific areas of the brain and then connecting the wires to a pacemaker-like device in the upper chest that, in turn, sends signals to the malfunctioning brain areas.

Richland Hospital was also the first in the Palmetto State to implant a diaphragm device that can significantly improve quality of life for those with spinal cord injuries. The implant helps strengthen the diaphragm. Another first for the state was the opening of the nation’s 66th Tuberous Sclerosis Complex (TSC) Clinic on the Richland campus. TSC is a rare genetic condition that affects 850 South Carolinians.

Further, Richland Hospital has added a new tool, Magseed, to improve accuracy in breast cancer treatment. A radiation-free, seed-like device is placed by a radiologist to mark the site of cancerous tissue and help with its precise removal. The hospital is the first in the Midlands to offer this procedure.

Expansions

Prisma Health Baptist Easley Hospital began construction on a new cancer facility, called the Larry Winn, MD, Cancer Care Unit. The \$1.9 million project will open in 2022 and allow patients to stay close to home to receive treatment.

A groundbreaking ceremony was held at Prisma Health Oconee Memorial Hospital to expand the Emergency Department (ED). The \$13 million project is slated for completion in 2023 and will more than double the current space, providing at least 22 new private treatment rooms.

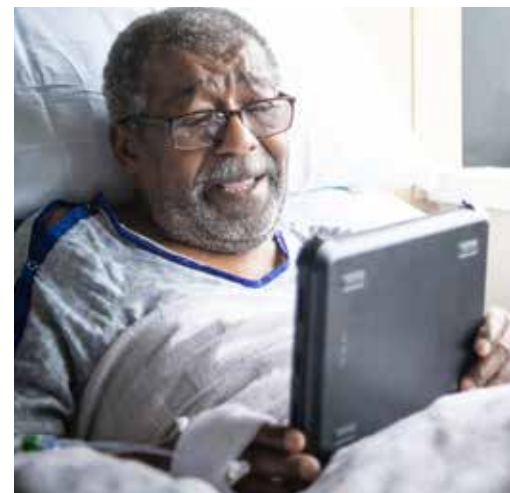
Similarly, Prisma Health Tuomey Hospital announced plans for a \$15.7 million expansion to its ED that will add 13,000 square feet and the latest technology. Nearly half of all ED visits in the state occur at a Prisma Health facility.

Prisma Health now has a Hemophilia Treatment Center in Greenville to join our established center in Columbia. The organization houses the state's only federally supported treatment centers, serving both adults and children.

Home Recovery Care, a program that makes possible hospital-at-home services, is now available through Oconee Memorial Hospital and Richland Hospital. Patients with acute, non-life-threatening medical conditions spanning approximately 150 diagnoses are eligible for this service. This care model keeps patients out of the hospital and provides nursing oversight, thus allowing them to avoid hospital-acquired infections while enjoying the comforts of home. The program was first offered at Prisma Health Greenville Memorial Hospital in FY20.

In Columbia, our reproductive and fertility service expanded to Prisma Health Baptist Parkridge Hospital, and a new Cancer Institute practice opened at Richland Hospital. Likewise, our organization opened a dermatology practice in Easley, and Prisma Health Orthopedics launched a new office in Greenville. North Greenville Hospital also greatly expanded its primary care walk-in clinic for patients needing same-day or urgent care.

Tuomey Hospital broadened its Advanced Heart Health Center with the addition of a heart valve clinic. It also implemented the CardioMEMS™ Heart Failure System, a wireless device that allows patients to monitor their pulmonary artery pressure at home. Prisma Health leads the country in use of this system, with more than 425 devices implanted in the last five years. The system markedly reduces heart failure hospitalizations and ED visits.





Partnerships and other initiatives

A new Mobile Mammography unit has been added to the Prisma Health fleet, making it more convenient for patients to get screened for breast cancer. During FY21, the units partnered with nearly 200 corporate and community entities to offer 4,288 mammograms on-site. In all, 24 breast cancers were found.

Our organization has begun a 10-year strategic relationship with medical technology company Siemens Healthineers to innovate healthcare. As part of this relationship, Prisma Health is upgrading major clinical technology to more modern systems that improve patient outcomes, reduce costs and enhance team members' skills. The organization is also collaborating with Siemens to develop new medical technology and software.

Prisma Health announced an agreement with Aetna to offer a new Medicare Advantage product for South Carolinians age 65+ and others eligible in Greenville, Spartanburg, Anderson, Pickens, Oconee, Laurens, Newberry, Lexington, Richland, Sumter, Fairfield and Kershaw counties. The goal is to connect consumers with an integrated solution to their healthcare needs. The focus is to improve coordination, clinical performance and efficiency of care for plan members.



LifeNet South Carolina, an air medical program, and Prisma Health have collaborated to offer additional air ambulance coverage. The partnership has established a base at the Pickens County Airport with a new aircraft with plans to upgrade the aircraft in the Midlands. The result will be improved air medical services, leading to quicker response times.

Prisma Health is one of 12 programs in the country to receive an "Alternative to Opioids" grant. As part of the grant, our pain management experts are working with our EDs to provide the best therapies that deliver pain relief and reduce the need for opioids.

As the state's largest, most comprehensive integrated healthcare company, Prisma Health can rapidly respond to supply chain challenges, securing critical medical supplies to ensure our patients and team members have what they need – no matter what the illness. Thanks to our talented Supply Chain team, Prisma Health can go directly to manufacturers to obtain supplies in bulk at reduced rates. Our organization can then quickly, conveniently and cost efficiently store and ship these items from our distribution center.

Awards and recognitions

Prisma Health received the 2020 GHX Excellence in Vendor Credentialing & Compliance award for the second year in a row. This award recognizes healthcare supply chain leaders who set the standard for best practices. Plus, our team received the Supply Chain of the Year award from the Emergency Care Research Institute.

Another company-wide honor was again being named a Most Wired organization by the College of Healthcare Information Management Executives for placing in the top quartile of facilities surveyed. The Most Wired program evaluates technology use to improve healthcare.

Prisma Health's Ambulance Service was the 2020 South Carolina Large EMS System of the Year. The state's EMS Association tapped the service team for "outstanding professionalism and service to communities and citizens."

Prisma Health Hillcrest and Patewood hospitals attained 5-star ratings from the Centers for Medicare & Medicaid Services – just 455 hospitals nationwide garnered top marks for quality performance. For a second year, these two facilities were also presented the Energy to Care Award from the American Society for Health Care Engineering for reducing campus energy consumption by 10% in a year.

Healogics named Tuomey Hospital's Wound Healing Center the Zone and Division Center of the Year for the Southeast, ranking fifth in the country for wound care.

Healthgrades lauded these Prisma Health hospitals with clinical awards in 2021:

- Baptist: 100 Best Hospitals for Joint Replacement; Stroke Care Excellence
- Baptist Parkridge: GI Services Excellence; Pulmonary Care Excellence
- Greenville Memorial: Coronary Intervention Excellence
- Oconee Memorial: Pulmonary Care Excellence
- Patewood: 100 Best Hospitals for Joint Replacement (third year running)

In addition, Prisma Health Greer Memorial Hospital earned Healthgrades' Outstanding Patient Experience Award in 2021. This honor is given to the top 15% of hospitals in the nation for patient experience.

These Prisma Health hospitals and their procedures/conditions were rated "High Performing," according to U.S. News & World Report:

- Baptist: back surgery (spinal fusion), heart failure, kidney failure, pneumonia
- Baptist Parkridge: both knee and hip replacements, colon cancer surgery, heart failure, kidney failure
- Greenville Memorial: heart attack, colon cancer surgery, lung cancer surgery, stroke
- Oconee Memorial: heart failure, chronic obstructive pulmonary disease (COPD)
- Patewood: both knee and hip replacements
- Richland: heart attack, heart failure, stroke
- Tuomey: COPD, heart failure, kidney failure





Prisma Health has 7 of the 10 best maternity care hospitals in South Carolina! In 2021, Newsweek/The Leapfrog Group named these hospitals among the best in the nation for maternity services: Baptist, Greenville Memorial, Greer Memorial, Laurens County, Oconee Memorial and Patewood. Baptist Easley Hospital was also recognized, but it is currently not birthing babies due to ICU capacity increases related to COVID-19.

Also honored by The Leapfrog Group was Baptist Parkridge as a Top Hospital for quality and safety – the sole hospital in South Carolina. Fewer than 6% of facilities earned this award. Plus, the group gave seven of our 10 (70%) eligible hospitals “A” grades in its spring 2021 Hospital Safety Grades report; only 33% of acute-care hospitals nationwide attained the top ranking.

Six of our hospitals were lauded by the American Heart Association (AHA) for offering high-quality stroke care:

- Baptist: Gold Plus Achievement/Quality Award
- Baptist Parkridge: Silver Plus Achievement/Quality Award
- Greenville Memorial: Gold Plus Achievement/Quality Award; Stroke Elite Plus, Honor Roll: Stroke Advanced Therapy, Honor Roll; Type 2 Diabetes, Honor Roll
- Greer Memorial: Gold Plus Achievement/Quality Award; Stroke, Honor Roll; Type 2 Diabetes, Honor Roll
- Hillcrest: Gold Plus Achievement/Quality Award; Type 2 Diabetes, Honor Roll
- Richland: Gold Plus Achievement/Quality Award; Stroke, Elite Plus, Honor Roll; Type 2 Diabetes, Honor Roll

Cardiac care accolades from the AHA also went to:

- Richland: Atrial Fibrillation, Silver; Heart Failure, Gold Plus; Resuscitation, Silver; STEMI, Gold

Applauded as a top performer in quality care was Hillcrest Hospital, named a 2021 Bernard A. Birnbaum, MD, Quality Leadership winner by Vizient Inc. among community hospitals. Rankings measure quality of patient care in five areas: safety, mortality, effectiveness, efficiency and patient-centeredness.

Baptist Easley Hospital was named 2020–2021 Outstanding Employer of the Year by the S.C. Division on Career Development and Transition, serving as a host site for Project SEARCH, which boosts employment opportunities for youth with disabilities (in partnership with the School District of Pickens County).

Prisma Health in the Midlands won the 2021 Champions for Education Award from the S.C. School Boards Association for our community health initiatives and overall support of schools. Also, Children’s Hospital in the Midlands was named May’s Hospital of the Month by Children’s Hospitals’ Solutions for Patient Safety Network. In the Upstate, our Center for Pediatric Medicine received the 2021 IBCLC Care Award (IBCLC stands for international board-certified lactation consultants) for training those who care for breastfeeding families, promoting breastfeeding and supporting the lactation consultant profession.

Accreditations, certifications, designations

The Prisma Health Cancer Institute was designated by the National Pancreas Foundation as South Carolina's first clinical Center of Excellence for pancreatic cancer. This status demonstrates that an institution provides multidisciplinary care while treating the "whole patient."

Baptist and Baptist Parkridge hospitals achieved Magnet® recognition, the gold standard for nursing excellence. Only 580 healthcare facilities worldwide – and under 9% in the United States – have reached Magnet status. Prisma Health has four of the seven Magnet-designated hospitals in South Carolina: The other two are Greenville Memorial and Greer Memorial.

Patewood Hospital attained international Baby-Friendly status for providing optimal care for infant feeding and mother/baby bonding. Ten of the 18 S.C. hospitals designated are part of Prisma Health: Baptist, Baptist Easley (currently not offering maternity services due to ICU capacity increases related to COVID-19), Baptist Parkridge, Greenville Memorial, Greer Memorial, Laurens County, Oconee Memorial, Richland and Tuomey hospitals.

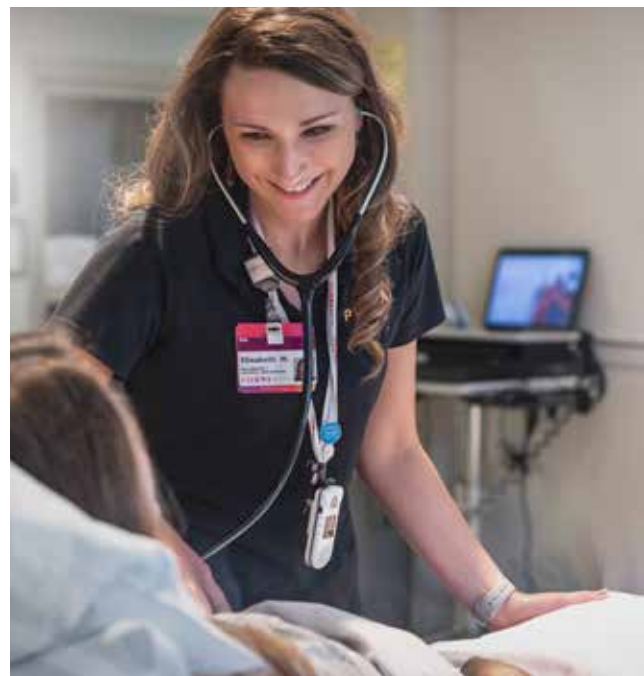
Hillcrest and Laurens County hospitals earned Primary Stroke Center certification from the Joint Commission in collaboration with the American Heart Association/American Stroke Association, joining Greer Memorial (recertified in FY21) and Oconee Memorial hospitals as facilities that provide high-quality stroke care to patients.

Hillcrest Hospital was named a Center of Excellence by Optum for bariatric surgery. And it was again recognized as the state's only Diagnostic Imaging Center of Excellence by the American College of Radiology.

BlueCross BlueShield of South Carolina designated these Prisma Health hospitals as Blue Distinction Centers (BDCs) for maternity care: Baptist Easley (not currently offering maternity care) and Richland, with eight other hospitals – Baptist, Baptist Parkridge, Greenville Memorial, Greer Memorial, Laurens County, Oconee Memorial, Patewood and Tuomey – reaching Blue Distinction Center+ (BDC+) status. Blue Distinction Centers are nationally designated hospitals with expertise in specialty care. A Blue Distinction Center+ demonstrates enhanced cost efficiency in delivering such care.

Additionally, Hillcrest Hospital was deemed a BDC for bariatric surgery. BDC honors for spine surgery went to Baptist, Baptist Parkridge, Greenville Memorial and Richland hospitals. Knee and hip replacement BDC designations were awarded to Oconee Memorial, Baptist Parkridge and Richland hospitals. Both Richland and Greenville Memorial hospitals were named BDCs for cardiac care.

Finally, 13 Prisma Health hospitals amassed 52 of the 223 Certified Zero Harm Awards (nearly 25%) given by the S.C. Hospital Association in 2021. These safety milestones focus on protecting patients by preventing hospital-acquired infections. Also included are four Drive to Zero Suicide Awards.

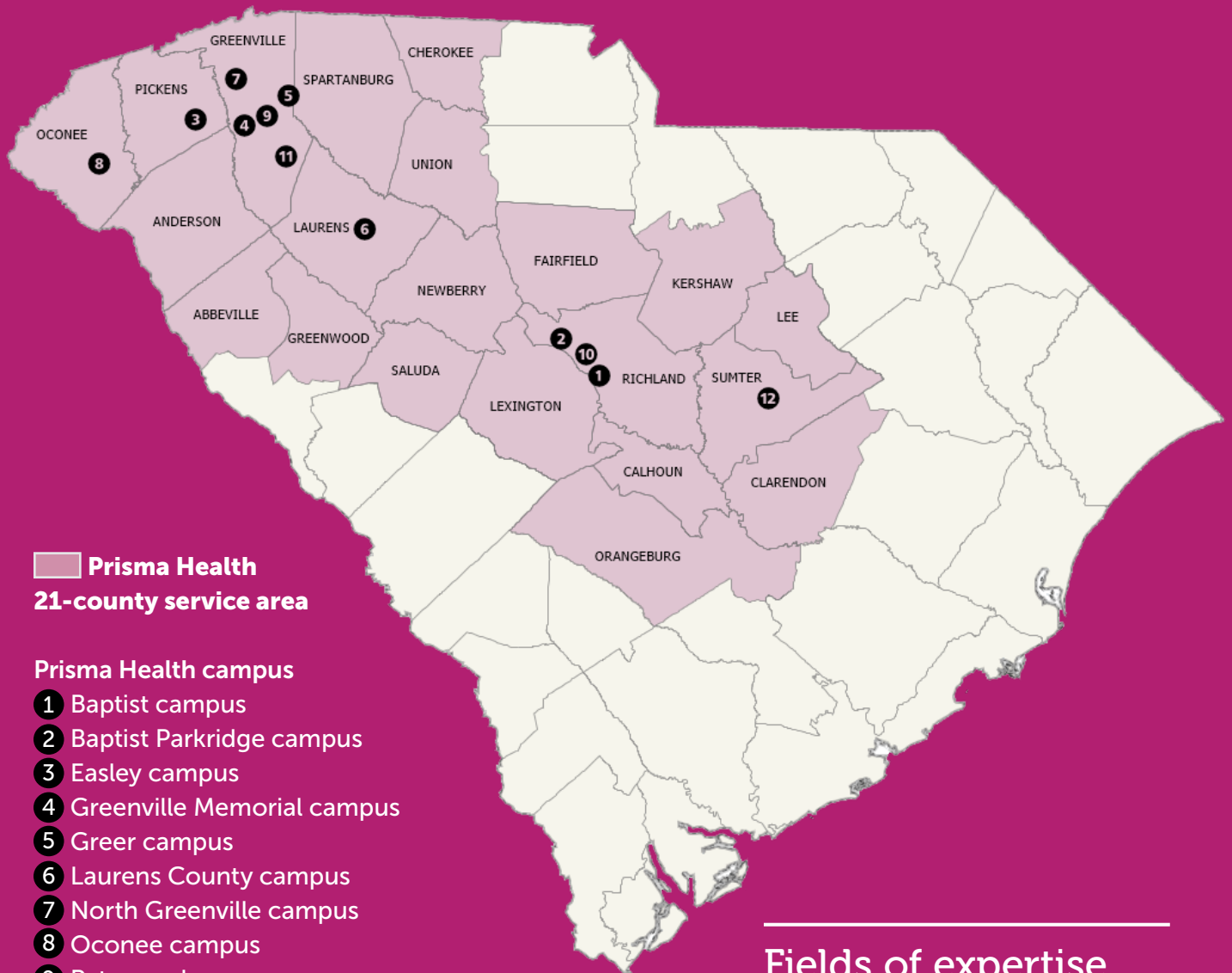
