Typical Schedule:	~6:00 AM – ~6:30 PM (Monday–Friday). The specific time to commence work rounds will be determined by the senior resident on the team on a daily basis and will be based on patient volume. Additionally, the visiting medical student will have overnight on-call responsibilities 2 calls per month and 2 Saturdays.
Course Objectives:	<ol style="list-style-type: none"> 1. Gain competency in the evaluation and management of medical complications during pregnancy, including Diabetes, Chronic hypertension, Asthma, Renal disease, and Thyroid disorders 2. Gain competency in the evaluation and management of obstetrical complications during pregnancy, including the topics of Preeclampsia-eclampsia syndrome, Preterm labor, Preterm premature rupture of membranes, and Third trimester bleeding 3. Gain competency in the evaluation and management of fetal complications during pregnancy, including Fetal growth abnormalities, Isoimmunization, and Congenital infections
Course Description:	<p>This Acting Internship is offered to students who have satisfactorily completed their third-year clinical rotations. The purpose of this course is to provide the learner with an intensive exposure to high-risk obstetrical care in an inpatient setting. Students will be exposed to a breadth of medical and obstetrical complications and fetal conditions. The student will be expected to function at the level of a PGY-1 resident, participating in clinical experiences in the Antepartum Ward and Labor and Delivery, as well as in the outpatient OB clinic under the direct supervision of resident and attending Maternal Fetal Medicine physicians.</p> <p>PATIENT CARE RESPONSIBILITIES (Inpatient Wards): Students will attend daily work rounds on antepartum patients with the High-Risk resident team. The senior resident or fellow will assign patients to the student to manage. The student will be assigned a minimum of 2 and no more than 4 patients to manage. Students will contribute to the care of their assigned patients by performing daily rounds, writing progress notes in the medical record, writing orders, and participating in deliveries, when applicable, under the direct supervision of residents and faculty. The student will follow their assigned patient through the antepartum and postpartum course (if applicable).</p>

TEACHING ROUNDS: Morning Report with the L&D and MFM attending of the week is conducted daily (Monday - Friday) at 7:00 am. The student will be prepared to present all patients for whom he/she provided care. The student will also perform walk-rounds with the MFM attending on Saturday morning during their call shift.

CONFERENCES: Students will attend all scheduled didactic sessions.
